Shri Dharmender Singh Son of Shri Jai Hind, Village Surakhapur Tappa Heveli, Tehsil Jhajjar, District Jhajjar (Haryana) recommended by the Haryana Staff Selection Commission, Panchkula vide their letter No. HSSC/Confd./Recomm/2019/1130 dated 21.01.2019 is hereby, offered appointment as Peon in Head Office Cadre of this Department on purely temporary basis in the Level-DL, Cell-1 Rs. 16900/- (Previous Pay Scale of Rs. 4440-7440+1650 GP) plus usual allowances sanctioned by the Haryana Govt. from time to time. your appointment in this department is subject to following terms and conditions:-

- 1. That your appointment is against purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent appointment is made to you at present. Consequently, your services may be terminated without any notice whenever there will be no vacancy against which he can be retained.
- 2. Your appointment is purely temporary and you will remain on probation for a period of two years.
- 3. If, at any stage, you desire to resign from their post, you will be required to give one month's clear notice or forfeit one month's salary including allowances in lieu thereof or for the period by which the notice falls short of one month. Such a notice will be given by the Department also to him in case it is proposed to terminate his services for the reasons other than that mentioned in the para-I above, in case of mis-conduct or mis-behaviour, he will be given a reasonable opportunity to show cause as to why his services may not be terminated. In that case, the condition of one month notice/salary will not apply.
- 4. That no Traveling Allowance will be allowed to you for the journey to be undertaken by you for joining the post.
- 5. That you will furnish an oath of allegiance to the Constitution of India in the form prescribed for Indian Nationals.
- 6. That you will furnish an Affidavit to the effect that neither you are dismissed employee of Government of any State or the Union Territory Government nor you are convicted of any offence involving dishonesty or moral turpitude or any case pending against you in any Court in the State or Indian Union.

As yours character and antecedents have not been got verified in terms of Govt. instruction issued vide Memo Bo. 52/3/2005- 6S (1) dated the 18 November, 2005 therefore, the same will be done after your joining. It is made clear to you that in case subsequently any adverse facts come to the notice of the State Government or Department regarding your character and antecedents, your services will be liable to be terminated without giving any notice.
- 8. It is made clear to you that if at any subsequent stage, any certificate of academic qualification, caste & categories is found to be fake/false, your services will be liable to be terminated and legal action will also be initiated against him in this regard.
- 9. Your seniority will be in fixed as per rules/instructions.
- 10. Further, it is made clear that your services will be governed under the Haryana State Cooperation Department Head Office and Sub-Offices (Group D) Service Rules 1991, amended Rules, 2018 and such other Rules as may be framed and instructions issued by the Government from time to time. Your services will be covered by the new defined Contribution Pension Scheme.
- 11. It is also made clear to you that you will not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for the preparation of higher studies.
- a) This offer is subject to the condition that in case you is married, you should have only one living spouse and if you are unmarried, you will have to furnish a declaration immediately after marriage regarding non acceptance of dowry by you to the concerned

authority as per declaration in Annexure-A and B in terms of Government instructions issued vide No. 18/1/2004-2GS-I, dated 21.02.2006.

- b) A declaration in writing that you were not on any previous occasion dismissed from service under any department of Government or convicted by a Court of Law or no case is pending against you in any Court of Law.
- 13. you have been exempted from medical examination by the competent authority as per rules 14 of HCS Rules, 2016 at the time of joining. Your joining will be subject to submission of medical fitness certificate after your joining and will be liable to be terminated if found unfit later on. The medical examination will be got conducted after joining of the candidate but will be submitted within 07 days of joining.
- 14. That this appointment is subject to the final outcome of CWP No. 37683/2018, 30376/2018, 23769/2018, 31085/2018, 32246/2018, 24327/2018, 26801/2018, 26478/2018, 37683/2018, 22969/2018 and 331/2019 etc. and any other writ petitions pending in the Hon'ble High Court and any other CWP pending in any other Court of Law.
- 15. You will be governed by Government Employees Conduct Rules, 2016 as amended from time to time and Haryana Civil Service (Punishment & Appeal) Rules, 2016. You will be governed by the provision of the Civil Service Rules and the relevant recruitment and condition of Service Rules as applicable to your post from time to time. For all other matters, not specified herein, you will be bound to fulfill the condition, subject to rules, regulations and instructions of Government as in force from time to time.
- 16. You must understand that if any information/deceleration furnished by you in connection with this appointment is as any time found to be false or incorrect, you will be liable to be dismissed from service and suitable action will be taken against you as per law.

If you are willing to accept this offer of appointment on the conditions mentioned above, you should report yourself for duty to this office immediately but not later than 15 days. In case, you fail to join your duty by this date, this offer of appointment will be treated as cancelled.
