## <u>ORDER</u>

In terms of Section 31(i) of the Haryana Cooperative Societies Act, 1984 and as recommended by the Selection Committee, the Governor of Haryana is pleased to appoint Sh. Rahul Uppal S/o Sh. H.S. Uppal, R/o A-5-II/23, NABARD Park, VM Bhargav Road, Santa Cruz (West), Mumbai as Chief Executive Officer/Managing Director, Haryana State Cooperative Apex Bank Ltd., Chandigarh on deputation basis on the following usual terms & conditions as per fit & proper criteria fixed by RBI/NABARD with immediate effect:-

- Pay: He will get the pay in the pay scale as he is drawing in his parent Bank and Special Pay of Rs. 10000/- per month.
- ii) **Dearness & others allowances:** He shall be entitled to Dearness Allowance. House Rent Allowance as per Haryana Government rates or as per the rates he is entitled in his parent Bank.
- iii) LTC & Medical facility: As per the Haryana Government Rules/instructions applicable to Managing Director of HARCO Bank or as per his entitlement in his parent Bank.
- iv) Residential Facility: Actual rent or upto Rs. 20,000/- per month whichever is less.
- v) **Travelling Allowance & Daily Allowance:** As per Haryana Government Rules/Instructions applicable to MD of HARCO BANK or as applicable in his parent Bank.
- vi) **GPF/EPF & Family pension contribution:** As per rates and terms &Conditions fixed by the parent Bank from time to time.
- vii) Leave salary, Gratuity, Administrative Charges of Provident Fund & Pension Contributions etc.: As per rates and terms & conditions fixed by the parent bank.
- viii) **Telephone Facility:** He will get telephone with internet facility at his residence subject to maximum of Rs. 5000/- per month, if not provided by the Bank.
- ix) **Disciplinary action:** On the request of current employer, he will be subject to disciplinary action to be taken by the parent Bank.
- x) DECLARATION: He will submit a declaration in the form of affidavit that no major penalty was awarded and no disciplinary action/criminal case in any court is pending against him.
- xi) **No Objection Certificate/Conduct Certificate:** He will submit No Objection Certificate from his parent employer at the time of joining.
- xii) Period of appointment: The period of appointment shall be initially for one year that may be extendable upto three years by the State Government on the recommendation of review Committee (consisting of Chairman HARCO Bank, RCS, Haryana & CGM NABARD) constituted for this purpose keeping in view of his performance on yearly basis. Continuation of service will depend on the performance which will be reviewed by the said committee on annual basis.
- xiii) He may exercise his option regarding point No. ii, iii and v above.

This appointment will be subject to final outcome of COCP No. 2785 of 2020 titled as 'Lokesh Devi Vs. Shanjeev Kaushal and another' and CWP No. 22433 of 2020 titled as 'Mukesh Kumar Goel Vs. Union Bank of India and others' pending in the Hon'ble Punjab and Haryana High Court, Chandigarh.

If the above terms & conditions of the appointment are acceptable to him, he would submit his joining report within a period of 15 days positively from the date of receipt of this communication.
