On the recommendations of the Haryana Public Service Commission, the Governor of Haryana is pleased to offer you appointment to the post of Assistant Registrar Cooperative Societies Officers in the Pay Level-7 of Schedule-1 of Pay Matrix as per notification No.1/20/2016(PR)-5PR(FD), dated 28<sup>th</sup> October, 2016 issued by Finance Department, Haryana plus usual allowances as are admissible under the State Government Rules on the following terms and condition:-

1. That you will get yourself medically examined by the Medical Board constituted by the Director General, Health Services, Haryana before joining. If you are found medically unfit your candidature will be cancelled.
2. The terms and conditions of your service including training, departmental examination, annual increment and probation period, etc. will be governed by the Haryana State Cooperative (Group-B) Service Rules, 1997 and the Haryana State Co-operative (Group-B) Services(Amendment) Rules, 2014 and other applicable rules/instructions as amended from time to time.
3. In case your work or conduct is not found satisfactory during the period of training/probation or the extended period of probation, your service shall be liable to be terminated at any time without notice or reasons being assigned.
4. This appointment is being issued with relaxation in verification of character and antecedents of candidates accorded by Chief Secretary Haryana vide U.O. No. 52/06/2020-3GSIII, dated 23.01.2020. Your character and antecedents will however be got verified in due course and in case any adverse report is found after verification, your services will be terminated without any notice or with reason to be assigned/recorded.
5. The verification of your educational qualifications, experience, age etc. has not

- (i) That if at any time during the course of your temporary appointment, any of the appointee desires to resign, he shall be required to give one month's clear notice or forfeit in lieu thereof his salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Government also in the case it is proposed to terminate his services in lieu thereof, the Government will be liable to pay him salary, including allowances for one month or for the period by which the notice falls short of one month.
- (ii) That no T.A. /D.A. will be granted for joining the post.
- (iii) The appointee shall produce a certificate before joining his duty to the effect that he has one living wife in case he is married. None of them who has more than one living wife shall be eligible for appointment to the post offered, unless, the Government, after being satisfied that there are special grounds for doing so exempt him for this condition.
- (iv) In case he is married, he will have to file a declaration about non acceptance/ giving of dowry. If he is unmarried, he shall have to furnish a declaration immediately after marriage regarding non acceptance/giving of dowry by him to the office as per the rule 13 of Haryana Civil Services (Government employees Conduct) Rules, 2016.
- (v) He must submit a declaration in writing that he was not on any previous occasion dismissed from service under any Department of Government or convicted by a Court of Law or no case is pending against him in any Court of Law.
- (vi) You shall not be eligible for appointment to the post if :-
  - (a) You have entered into or contracted a marriage with a person having a spouse living; or
  - (b) You having a spouse living have entered into or contracted a marriage with any person.

If you are willing to accept this offer on the above terms and conditions, you are hereby directed to join as Assistant Registrar Cooperative Societies in this office, immediately, but not later than fifteen days from the date of receipt of this letter, failing which it will be presumed that you are not interested in this offer and it will stand cancelled.
