Sub: Grant of Traveling allowance and Sitting fee to the Members of the Managing Committee of Cooperative Institutions.

Ref.: This office Memo No. 7/1/2010/Gen.I/4902-5072 dated 20.06.2013.

The matter regarding enhancement of TA/DA to members of the Board of Directors of the Cooperative Institutions has been further considered and it has been decided that the TA/DA to be paid to the non-official members of the Board of Directors of the Cooperative Institutions other than MLAs /MPs be increased category-wise. The Cooperative institutions have already been classified in three Groups (Group A, B & C). The new rates are as under:-

Groups	In Haryana	Outside Haryana/Other Town above 20 lakhs population
I) Group-A	Rs. 650/- per day	Rs. 800/- per day
II) Group-B	Rs. 550/- per day	Rs. 750/- per day
III) Group-C	Rs. 500/- per day	Rs. 650/- per day

Further, the mileage for Group-A will be Rs. 16/- Km of journey performed by own car or Taxi, for Group-B will be Rs. 12/- per Km. for own Car or Taxi and for Group-C will be Rs.9/- for own Motor Cycle or Auto Rickshaw of the journey

performed for notified place of residence to office premises where meetings are scheduled to be held and for back journey to place of residence.

These instructions will come into force with immediate effect.
