In Exercise of the powers conferred by Section 37 of the Haryana Cooperative Societies, Act 1984, the undersigned being the Registrar Cooperative Societies Haryana makes the following rules further to amend the Staff Service Rules of the Primary Cooperative Marketing cum processing Societies Ltd. Staff Service Rules namely:

These rules may be called the Primary Cooperative Marketing cum processing Societies Ltd., Staff Service Rules (First Amendment) 2011 in the Primary Cooperative Marketing cum processing Societies Ltd., Staff Service Rules, 2003, rule 3&4 shall be substituted as under:-

Rule No.	Existing Provision	Amended Provision
3.	Powers to make appointment shall lie with the B.O.D./B.O.A. of the Society which may alter, amend, add or withdraw any of the rules herein from time to time subject to prior approval of the Registrar, Coop Societies Haryana.	Powers to make appointment shall vest with the B.O.D./B.O.A. of the society. Further provided that decision for appointment to various categories of service shall be taken in the meeting in which the presence and concurrence of concerned Assistant Registrar, Inspector, Coop. Societies & Distt. Manager, Hated, shall be compulsory. Any addition, alteration or amendment in the service rules will be subject to prior approval of Registrar, Coop. Societies, Haryana.
4.	These rules vest in the B.O.D./B.O.A. which is also empowered to issue such instructions as may be necessary to give effect to and carry out the purposes of the provisions of these rules or otherwise to secure the effective control of the staff of the marketing society.	The power to exercise these rules vests with the B.O.D./B.O.A. Provided that the decision to issue instructions as may be necessary to give effect and carry out the purpose of these rules will be taken only in the meetings which are actually attended by Assistant Registrar, Inspector, Coop. Societies & Distt. Manager, Hated.

The above amended rule shall be effective prospectively and not retrospectively and will be applicable to the employees of the Cooperative Marketing-cum-Processing Societies only from the date of issue of this amendment.
