ORDER

In exercise of the powers conferred by section 37 of the Haryana Cooperative Societies Act, 1984 and in consultation with the Primary Cooperative Marketing-Cum-Processing Societies working in State of Haryana at Mandi level, the undersigned being the Registrar, Cooperative Societies, Haryana makes the following rules further to amend the Staff Service Rules of the Primary Cooperative Marketing-Cum-Processing Societies Ltd., Staff Service Rules namely:-


1. These Rules may be called the Primary Cooperative Marketing-Cum-Processing Societies Ltd., Staff Service Rules (First amendment), 2014.
2. In the Primary Cooperative Marketing-Cum-Processing Societies Ltd., Staff Service Rules, 2003, Rule 6 shall be added/amended as under:-

6. **Staff Strength**

- (a) The staff for different categories of societies will be as per Annexure A.
- (b) **Financial Liability** :- The pay and allowances of the Managers Co-op. Marketing Societies on common cadre, running in profits shall be borne by the Co-op. Marketing Societies themselves and pay & allowance of the Managers of Co-op. Marketing Societies in loss shall be borne by The Haryana State Co-op. Supply & Marketing Federation Ltd: (HAFED) as per present practice in force till the Society earns Profit in excess of the Salaries being drawn by them during the year.
- (c) **Ex-Gratia Assistance**:- In case of death of a regular employee during the service, a lump-sum Ex-gratia Assistance of Rs. 2.50 laes shall be provided to the dependents of the deceased or as per instructions issued by Registrar, Co-operative Societies, Haryana from time to time.

The above amended rule will be applicable of the regular employees of the Primary Cooperative Marketing-Cum-Processing Societies with immediate effect.


