ORDER

The following Peons working in the Field Offices are hereby promoted as Clerks on purely temporary basis in the Pay scale of Level-2 plus all usual allowances admissible under the Rules. Their promotions are subject to the approval of the Staff Selection Commission, Haryana, Panchkula and subject to the condition that they can be reverted to the post of Peon at any time without any notice.

Their promotions shall be subject to the following conditions:-

- 1. Further, it is made clear that in case out of above promotee employees, any junior employee joins before his senior, he will have no claim of senority over his senior on the basis of his/her earlier joining to the above post.
- 2. They have to qualify the State Eligibility Test in Computer Appreciation and Applicantion (SETC) within a period of probation.
- 3. The ACR have not yet been finalized following Sr. No. 2, 3 & 5 and hence they would be liable to be reverted without any prior notice if their integrity is subsequently found doubtful.
- 4. They shall remain on probation of period of one year which can be extended for a further period of one year in case of unsatisfactory works.
