The names of Shri Pardeep Kumar (Seniority No. 82) and Shri Pardeep Kumar (Seniority No. 96) Sub Inspectors were considered for promotion to the post of Inspector, Cooperative Societies but they were not found fit for promotion due to the pending effect of punishment awarded to them in disciplinary proceedings under the Punishment & Appeal Rules.

The above promotions will be subject to the following conditions:-

1. That if adverse remarks regarding Integrity are found in their ACR for a relevant period at a later stage, they will be reverted to the post of Sub Inspector without any notice;
2. That for any administrative reasons, if an employee will be found senior, the seniority will be determined on the basis of that order;
3. That in case any employee of the PHC category will be found eligible for promotion at any point as per the Act, Rules or Instructions of the Government issued from time to time, the junior most employee will be reverted to the post of Sub Inspector without any prior notice;
4. That the probation period will be as per Rule 27 of the HCS (General) Rules, 2016;
5. Further, it is made clear that in case out of above promoted employees, if any junior employee joins before his senior, he will have no claim of seniority over his senior on the basis of his/her earlier joining to the above post;
6. That the Service Rules of 1980 with amendments shall be applicable to govern the services of these employees.

They should join their new assignments immediately.


