ORDER

Whereas Shri Mahinder Kumar and Shri Rajesh Sub-Inspectors were promoted as Statistical Assistants vide orders dated 21-08-2020 issued under Endst.No. Admn.II(2)/11242-90 dated 25.08.2020 accordingly, they joined there duties as such in the offices of Assistant Registrar, Cooperative Societies at Panipat and Gurugram respectively.

Shri Mahender Kumar vide his application dated 12-10-2020 and Shri Rajesh vide his application dated 14.09.2020 supported with Affidavits made a request that they do not want to take promotion due to their domestic circumstances.

Both these officials were called for personal hearing on 27-10-2020. As a consequence on their reversion, withdrawal of their ACP and no consideration of their promotion in future was educated to them during the hearing even then they also gave in writing to forego their promotion.
