3. Their seniority will be determined as per Rule-11 of the Haryana State Co-operation Department, Head Office and Sub-Offices (Group-C) Service Rules, 1989, Amended Rules, 2013;
4. The officials not found yet eligible will have their right to be senior to the above officials as per record and thus, these officials will have no claim of being senior to them at that time on the basis of this promotion order;
5. That their services will be governed under the Haryana State Co-operation Department, Head Office and Sub-Offices (Group-C) Service Rules, 1989, Amended Rules, 2013, Haryana Civil Services (General) Rules, 2016 and such other rules as may be framed thereunder and instructions issued by the Government from time to time.


