The Haryana Staff Selection Commission, Panchkula vide it's letter No.HSSC/Confd/Recomm/2020/238 dated 20.06.2020 has recommended the following candidateds for the post of peon and accordingly, they are, hereby, offered the appointment as Peon in Head Office Cadre of this Department on purely temporary basis in the Level-DL, Cell-1 Rs. 16900/- (Previous pay Scale of Rs4440-7440+1650GP) plus usual allowances sanctioned by the Haryana Govt. from time to time.

- That no offer of permanent vacancy is made to you at present as your appointment is against purely temporary post which may be liable to be abolished at any time, hence, carries no promise of subsequent permanent employment. Consequently, your services can be terminated without notice whenever there will be no vacancy against which they can be retained;
- Their appointment is purely temporary and they will remain on probation for a period of two years. (Rule 27 of Haryana Civil Services Genrel Rule 2016);
- 3. If, at any stage, they desire to resign from their post, they will be required to give one month's clear notice or forfeit one month's salary including allowances in lieu thereof or for the period by which the notice falls short of one month. Such a notice will be given by the Department also to them in case it is proposed to terminate their services for the reasons other than that mentioned in the para-I above, in case of mis-conduct or mis-behaviour, they will be given a reasonable opportunity to show cause as to why their services may not be terminated. In that case, the condition of one month notice/salary will not apply:
- 4. That no Traveling Allowance will be allowed to them for the journey to be undertaken by them for joining the post;
- 5. That they will furnish an oath of allegiance to the Constitution of India in the form prescribed for Indian Nationals;
- 6. That they will furnish an Affidavit to the effect that neither they are dismissed employee of Government of any State or the Union Territory Government nor they are/were convicted of any offence involving dishonesty or moral turpitude or any case pending against them in any Court in the State or Indian Union;
- 7. As their character and antecedents have not been got verified in terms of Govt. instruction issued vide Memo Bo. 52/3/2005- 6S (1) dated the 18 November, 2005 therefore, the same shall be done after their joining. It is made clear to them that in case subsequently any adverse facts come to the notice of the State Government regarding their character and antecedents, their services will be liable to be terminated without giving any notice;
- 8. That subject to authenticity of their academic qualifications, caste and category certificates which have also not been verified/checked from the issuing authority, therefore, it is made clear to them that if at any subsequent stage, the same will be found to be fake/false, their services will be liable to be terminated and legal action will also be initiated against them in this regard;
- 9. Their seniority will be in fixed as per Rules/Instructions;

- 10. Further, it is made clear that their services will be governed under the Haryana State Cooperation Department Head Office and Sub-Offices (Group D) Service Rules 1991, amended Rules, 2018 and such other Rules as may be framed and instructions issued by the Government from time to time. Their services will be covered by the new defined Contribution Pension Scheme;
- 11. It is also made clear to them that they will not undertake higher studies of any kind without obtaining prior permission. Consequently, no leave of any kind will be granted for the preparation of higher studies;
- a) This offer is subject to the condition that in case they are married, they should have only one living spouse and if they are unmarried, they shall have to furnish a declaration immediately after marriage regarding non acceptance of dowry by them to the concerned authority as per declaration in Annexure-A and B in terms of Government instructions issued vide No. 18/1/2004-2GS-I, dated 21.02.2006;
  - b) A declaration in writing that you were not, on any previous occasion, dismissed from service under any department of Government or convicted by a Court of Law or no case is pending against you in any Court of Law;
- 13. That they shall furnish an undertaking to the Govt. in Form-C that they will maintain all the other members who were completely dependent on the martyr, and in case it is proved subsequently that the family members are being neglected or are not maintained by them, their services will be terminated forthwith;
- 14. That you should appear before the concerned Civil Surgeon immediately and furnish the Medical Certificate of fitness for Govt. Service issued by concerned Civil Surgeon befor Joining the post of Peon;
- 15. That this appointment is subject to the final outcome of CWP No. 37683/2018, 30376/2018, 23769/2018, 31085/2018, 32246/2018, 24327/2018, 26801/2018, 26478/2018, 37683/2018, 22969/2018 and 331/2019 etc. and any other writ petitions pending in the Hon'ble High Court and any other CWP pending in any other Court of Law;
- 16. Your services will be subject to Government. Employees Conduct Rules, 2016 as amended from time to time and Haryana Civil Service (Punishment & Appeal) Rules, 2016. You will be governed by the provision of the Civil Service Rules and the relevant recruitment and condition of Service Rules as applicable to your post from time to time. For all other matters, not specified herein, you will be bound to fulfill the condition, subject to Rules, regulations and instructions of Government as in force from time to time;
- 17. You must understand that if any information/deceleration furnished by you in connection with this appointment is as any time found to be false or incorrect, you will be liable to be dismissed from service and suitable action shall be taken against you as per law.

If you are willing to accept this offer of appointment on the conditions mentioned above, you should report yourself for duty to this office immediately but not later than 15 days. In case you fail to join your duty by this date, this offer of appointment will be treated as cancelled.
