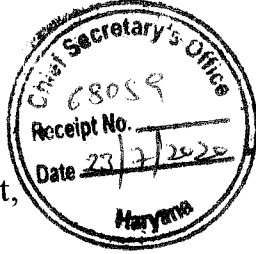

Respected Sir

In reference to earlier letter no. 4798/2020 HCBA dated 18.07.2020, a reminder letter is sending to your goodself that the High Court Bar Association has received many complaints verbally and in writing with regard to the functioning of the ACS, Cooperation, Special Secretary to ACS, Cooperation Department and also Registrar, Cooperative Societies.

It has been brought to our notice that no social distancing is being maintained while hearing of cases and no precautions are being taken, in view of the situation. Since pandemic Nobel coronavirus covid-19 is a major threat to all the human beings and hence there should be no physical hearing of the cases. Only the urgent matters may be taken up that too through video conferencing facility and if somehow any party is unable to come to the Hon'ble Court and does not appear then, no adverse order be passed against them. Matters be adjourned at least for two months. All the orders and cause lists be also uploaded on the website as being repeatedly directed by this Hon'ble High Court especially in CWP number 9324 of 2017 vide order dated 4th May 2017.
