In this regard, it is informed that a State Level workshop on "Integrated Development of Co-operative-Transforming PACS into Multi-Purpose Societies" organized by HARCOFED on 30-05-2018 at Red Bishop Resort, Panchkula under the Chairpersonship of W/ACS, Cooperation, in which it was decided that PACS/PCCS will venture into new activities in order to make them true multipurpose societies and to improve their financial position. In the workshop, Director, Agriculture had briefed the participants about the Custom Hiring Centers Scheme implemented by the Department of Agriculture and Farmers Welfare with Govt. of India support. Accordingly a detailed instructions have been issued to all DRCS and ARCS vide letter dated 01.06.2018 (copy enclosed) to shortlist five PACS in their area for the above said purpose.

In view of above letter dated 01.06.2018, many PACS/PCCS submitted applications to the Agriculture Department for setting up of CHCs. For this purpose, PACS/PCCS require loans from respective DCCBs. Now various field offices have informed that DCCBs are not providing/facilitating for loans to the PACS/PCCS for setting up of CHCs. W/ACS, Cooperation has also taken a serious view in this regard.

Hence, you are directed to further direct all General Managers of DCCBs to take immediate steps in the matter.

Subject:- Setting up of Custom Hiring Centers (CHCs) by Primary Agriculture Cooperative Societies (PACS).

Please refer to the subject cited above.

In the State Level Workshop on "Integrated Development of Co-operatives- Transforming PACS into Multi-Purpose Societies" organized by HARCOFED on 30-05-2018 at Red Bishop Resort, Panchkula, it was decided that the PACS will venture into new activities in order to make them true multipurpose societies and to improve their financial position. A number of activities were suggested by the participants which have the potential to improve the functioning of the PACS. The Director Agriculture had briefed the participants about the Custom Hiring Centers Scheme implemented by the Department of Agriculture and Farmers Welfare with Govt. of India support. It was decided that maximum number of CHCs will be set up by the PACS. The details of the scheme are enclosed.

To implement the above decision it has been decided that all ARCSs will shortlist five PACS in their area for setting up of Custom Hiring Centers. The applications for availing assistance/ subsidy for establishment of the Custom Hiring Centers are required to be submitted to the Agriculture Department by 15th June, 2018. To achieve this goal, all ARCSs are directed to call a meeting of the PACS in their area by 8th June, 2018 in which the Prabandhak, another official of PACS, the President and Secretary of the society should participate. The local

officers of the Agriculture Department should be consulted for more details about the scheme and the procedure to be followed for submitting the application to the Agriculture Department.

The ARCSs will ensure that the applications are duly submitted to the Agriculture Department before 15th June,2018. The DRCS will monitor the progress on daily basis and keep the Head office informed of the progress through E-mail/Whatsapp.
