

Subject: Regarding joining of selected candidates in Group D recruitments conducted by Haryana Staff Selection Commission.

All Administrative Departments are hereby informed that Haryana Staff Selection Commission has announced the results for Group D recruitments for 18218 jobs offered across 74 Departments (list attached as Annexure 1).

Subsequently, Commission would be informing selected candidates about their Post and the Departments they are expected to join.

Information in this regard has been communicated to all candidates. Candidates are expected to contact the Department from 22.01.2019 onwards.

2. In this regard, Administrative Departments are requested to note the following:

- i. Candidates would be expected to join starting on 22.1.2019.
- ii. Departments need to nominate one officer to manage joining of recommended candidates i.e. department's nodal officer for recruitment or any other officer.
- iii. HSSC (through HKCL) would also email the recommendations to Depts. on the email id of the nodal officers (list attached as Annexure 2). Document is password protected and would be sent on the Mobile Number of the nodal officers.
- iv. A CD/DVD/Hard Disk carrying application forms (including other documents) of all recommended candidates has been prepared and nodal officers of the departments may collect them from the office of Haryana Staff Selection Commission.


3. The Departments need to take the following actions:

- i. Departments are expected to make necessary arrangements to facilitate easy and efficient joining of candidates.

- ii. It is suggested that Departments print all the application forms of recommended candidates on receipt of the CD/DVD/Hard disk and arrange the necessary logistics for the same i.e. computers, printers, etc.
 - iii. If applicable, Departments may conduct counselling of candidates and take choice of candidates in respect of place of posting.
 - iv. Due to bye-election in Jind district, all the vacant posts of Jind district shall not be filled up before January 31, 2019.
 - v. Similarly, all candidates who are residents of Jind, shall not be allowed to join before 31st of January 2019, even if their appointment is to be offered in any other district.
 - vi. Departments have to update status of joining of candidates in a Tracker through the weblink that has been provided at : <https://goo.gl/JM7nTB>.
 - vii. In respect of medical certificate before joining, attention is drawn to Rule 14 of HCS Rules, 2016 wherein the competent authority has power to exempt candidate from medical examination. Concerned competent authorities may use the provision to exempt candidate from requirement of medical certificate.
4. All Departments are directed to ensure that the joinings are completed at the earliest.
